PUBLIC NOTICE

In view of the strategy taken to control and prevent dogs in public places within the town of Siaha, the Executive Committee of the Mara Autonomous District Council, in exercise of the power conferred under **Sub-Section (2) of Section 3 of the Mara Autonomous District Council (Animals Control and Taxation) Amendment Act 2018**, is pleased to issue the following guidelines for handling of dogs in public places so as to ensure the safety of both dogs and the public, and promote cleanliness within the town of Siaha.

1. All dog's owners must ensure that their pets are restricted and confined within their residence or compound, and that their pets are leashed on a leash (chained) in all public places within the town of Siaha. Further, it will be the duty of the dog's owners to pick-up the waste products of their pets in all public places and dispose such waste in the most hygienic and appropriate manner.
2. All dog's owners must collect a dog's collar, in which a registration code will be entered and panned down, on payment of a fixed amount of money form the Local Administration Department, MADC during regular office hours from 1<sup>st</sup> April, 2024. Any dog found in any public place without a collar will be considered as stray i.e. ownerless.
3. Any dog found in a public place shall be impounded by the authority concerned and if such dog is not collected by its owner within a stipulated period, it will be auctioned without any further information.
4. If any dog is found in any public place, the public will have the right to report about such unattended dog to the Anti-Dog Squad by providing the name and address of the owner, and the place where it is found, at the below-mentioned phone numbers. Such reporter(s) will be rewarded as considered appropriate by the authority.
5. Any other information or query relating to the prevention and control of dogs in public places may be acquired or inquired from the Local Administration Department, MADC or at the below-mentioned phone numbers during regular office hour. All pet's owners must comply with the above-mentioned guidelines. Failure to comply will result in stringent actions.




