5. **Eligibility Conditions** :
 - a) He must be a citizen of India
 - b) He must be a permanent resident of Mara Autonomous District by birth or descent.

d) Minimum Physical Measurement Required:

e) Computer Proficiency: Applicants are required to provide a certified document of Computer Proficiency with a minimum degree of Diploma in Computer Applications (CCA) or equivalent.

f) Working knowledge of Mara language of at least Middle School standard.

g) Age Limit:

He/She must be aged between 18 and 35 years on the last date of application. Upper age limit relaxation will be as per Notification No.A-12011/1/2019-P&AR(GSW) dt.3.6.2019 (published in the Mizoram Gazette Extraordinary, Issue No. 375 dt.10.6.2019) as amended from time to time. For age proof, HSLC/HSSLC Certificates which clearly shows the candidate's date of birth shall be accepted. In the absence of date of birth in such certificates, the relevant documents issued by the competent authority may be accepted.

Provided that for advertisement made during calendar years of 2023 and 2024, the candidate must not have exceeded the age of 37 years on 1st August of the particular calendar year.

Documentary support to proof all eligibility conditions should not be dated later than the last date of application.

6. Disqualification :

- i) Canvassing by a candidate directly or indirectly will disqualify the candidate.
- ii) Any candidate who, on verification at any stage of the recruitment process, does not fulfill any of the eligibility conditions, will be disqualified.

7. The selected candidate will be liable for his own expenditures.

8. The Executive will not be bound to appoint any candidate after completion of his/her training.

9. (I) Written Examination.

The written examination shall be held in the following manner :-

2. Mara Subject - 50 Marks
3. English (Essay and precis writing etc.) - 50 Marks

Optional Subjects :

4. Any two subjects out of the following. Candidates have to undertake the questions of the chosen optional subjects and the standard of these subjects shall be that of a Bachelor's degree.

- xi. Physics
- xii. Statistics
- xiii. Veterinary Science
- xiv. Zoology

Note: No candidate shall be allowed to take more than one subject of the group (i) Agriculture, Agricultural Engineering and Veterinary Science (ii) Chemistry and Chemical Engineering (iii) Computer.


